THESE PROJECTS ENSURE THAT VICTIMS HAVE ACCESS TO TRAINED NO COST, PRO BONO, AND LOW BONO ATTORNEYS AND ADVOCATES TO SECURE FOR THEM MEANINGFUL RIGHTS THROUGH THE EXERCISE OF THOSE RIGHTS IN STATE, FEDERAL, MILITARY AND TRIBAL TRIAL AND APPELLATE COURTS NATIONWIDE.
