## Online Resources: Victim Impact Statements

*One of the rights commonly guaranteed to victims is the right to be heard, and one key moment in which this right may be exercised is in connection with sentencing proceedings. One way to be heard in connection with sentencing proceedings is through a victim impact statement, which may take a number of forms. Statements may be written, video or audio recorded, or leverage other technology-enhanced formats. Statements may also be spoken or read aloud by the victim or their representative in person, or victims may choose to have their statements facilitated with remote participation using videoconferencing, telephone, or other technology. A victim's right to be heard is personal to them, and they may choose to exercise or waive the right.*

*This compilation of resources and sample statements is for reference only and has been created to assist victims, victim advocates and victims' rights attorneys as they think about victim impact statements. Some of these materials may contain jurisdiction-specific guidance or information; contact a local victim advocate, victims' rights attorney or prosecutor's office for more information about the processes and procedures in your area.*
