VICTIM LEGAL ASSISTANCE - SINCE 2003, NCVLI HAS BEEN LEADING THE NATIONAL EFFORT TO ENFORCE VICTIMS' RIGHTS THROUGH ITS CRIME VICTIMS' RIGHTS ENFORCEMENT PROJECTS. THESE PROJECTS ENSURE THAT VICTIMS HAVE ACCESS TO TRAINED, NO OR LOW COST (PRO BONO, AND LOW BONO) ATTORNEYS AND ADVOCATES TO SECURE FOR THEM MEANINGFUL RIGHTS IN STATE, FEDERAL, MILITARY AND TRIBAL TRIAL AND APPELLATE COURTS NATIONWIDE. THIS PAST YEAR, ACCOMPLISHMENTS OF NOTE WERE MANY - SOME WERE ONGOING EFFORTS AND OTHERS AS NEW INITIATIVES. THE WORK OF THREE ONGOING PROJECTS ARE NOTED HERE. FIRST, TO ENSURE NATIONAL CAPACITY NCVLI CONTINUED PROJECTS THAT PROVIDE TRAINING AND TECHNICAL ASSISTANCE NATIONWIDE TO GROUPS CREATING AND OPERATING VICTIM LEGAL ASSISTANCE EFFORTS TO ENSURE SURVIVORS HAVE ACCESS TO LEGAL SERVICES AT NO COST WITH A FOCUS ON RIGHTS ENFORCEMENT.
